- 1. Call to order Start recording the meeting: Recording started @5:03PM.

- 3. Approval of previous meeting minutes -1/10/24: Larry motions to pass minutes after the date of minutes is changed from 1/10/23 to 1/10/24. Second by Chris. Motion passed.
- 4. Chair Report: Contract and Construction Grant Agreement updates. Universal Service Plan Report Update (post on website, send to town selectboards, other). 2024 Task list, exec director search, Laura states that contract with Consolidated(CCI) is signed. CCI will submit an invoice for first payment per grant agreement. Grant agreement is not signed but may be signed this week or next. CCI will provide a detailed report of plans for construction. VCBB will get back to Occud on Friday after recent markups. GoNetSpeed(GNS) agreement is moving along. GNS will provide Occud with a corrected map of their territory for Occud CUD and an updated/finished address list. GNS is challenging a dozen addresses in their territory that have been covered by CCI. Mike asked when agreement with GNS would be signed. Laura and Leslie think that it will happen Friday. Mike asks if agreement, maps and address lists will be available on a shared drive. Laura says yes and please remind her. The Universal Service Plan report update is still being worked and is pending for the aforementioned agreements.

Executive Director RFP has been posted in a couple of places and Laura has spoken to a couple of HR consultants. They say that because the position is part time, temporary and specialized work, it may be difficult to fill. The consultants suggest a breakdown of tasks for the position. Perhaps folks could be hired for specific tasks. Perhaps Vantage Point could be used for tasks related to financial reporting and other financial requirements and procedures and more. Vermont Digital Equity Plan is moving forward and is submitted. Although ACP is gone, CCI will continue to provide some discounts to customers.
