- 3. Approval of previous meeting minutes 8/14/24, and 9/18/24. (note that 9/11/24 had no quorum), and 9/23/24. Motion by Larry, second by Mike, Approved by all except recusal by Leslie for Aug 14 minutes.
- 4. Chair Report on OCCUD business:
 - Report on submissions to VCBB Pre-construction Grant amendment and sustainability plan were approved (unanimously 4:0) by the VCBB at the September VCBB meeting.
 - b. Report on CUD-Triad Sustainability Committee.
 - c. 2024 Annual Report and 2025 Budget. Laura presented draft/outline. Committee approved moving forward to final draft and presenting it to Governing Board for their review/input. Leslie confirmed due date of Oct 21 to VCBB and member towns' municipal legislators.
